ORDINANCE NO. 1118-2022

**AN ORDINANCE AMENDING PORTIONS OF CHAPTER VII, ARTICLE I, TITLED "TRAFFIC" OF THE
REVISED GENERAL ORDINANCES OF THE BOROUGH OF PEAPACK AND GLADSTONE**

WHEREAS, pursuant to Title 39 of the Revised General Statutes of the State of New Jersey, N.J.S.A. 39:4-197 et seq., a governing body of a municipality may regulate the parking of vehicles upon land owned by the municipality, including any lands devoted to the public parking of vehicles, the entrances thereto and exits therefrom; and

WHEREAS, consistent with its statutory authority, the governing body of the Borough of Peapack and Gladstone previously enacted Chapter VII, Article I, of the Municipal Code of the Borough of Peapack and Gladstone, entitled "Traffic", which sets forth various regulations with respect to traffic and parking on the streets in the Borough of Peapack and Gladstone; and

WHEREAS, the governing body of the Borough of Peapack and Gladstone has deemed it fit to amend portions of its Traffic ordinance in order to accommodate adequate parking for users of the newly renovated Liberty Park, for access the park and for the benefit of the residents of the Borough.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Peapack and Gladstone, in the County of Somerset and State of New Jersey, as follows:

Section 1. Chapter VII, Article I, Section 13 of the Traffic Ordinance of the Borough of Peapack and Gladstone, is hereby amended as follows:

§7-13.1 Certain Parking Prohibited During Certain Hours on Park Avenue; Exceptions.

No person shall park a vehicle in any parking spot on Park Avenue adjacent to Liberty Park between the hours of 6:00 a.m. to 9:00 p.m. any day, unless that person intends to and does immediately thereafter enter into the park. Once such an individual leaves Liberty Park, that individual must immediately move their vehicle from any such parking space.

Section 2. All ordinances or parts of ordinances inconsistent with or in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. This Ordinance shall take effect immediately upon: (i) adoption; and (ii) publication in accordance with the laws of the State of New Jersey.
