To All Dog Owners:

Dog licenses must be obtained by March 1, 2019, from the office of the Borough Clerk, at Municipal Complex, 1 School Street, PO Box 218, Peapack, NJ 07977.

License fees are \$21.00 per spayed or neutered dog and \$24.00 per non-spayed or non-neutered dog. A late fee of \$10.00 will apply after March 1, 2019.

***Borough Code 8-2.5(b) – For the Calendar Year 2013. The person applying for the license shall pay a fee of nineteen dollars and eighty cents (\$19.80) for each dog. He/She shall also pay one dollar and twenty cents (\$1.20) for the registration tag for each dog as required by the State of New Jersey. An additional tag fee of three dollars (\$3.00) will be charged if the owner does not produce a certificate of alteration for his/her dog. The same fees shall be charged for each annual renewal of each license until such time as that fee may be changed by ordinance. (Ord. No. 661 § 2; Ord. No. 875; Ord. No. 963)***

Puppies must be licensed after the age of six months.

***License application and payment will be returned to owner if a valid copy of the rabies certificate is not attached or if the rabies certificate does not cover at least through October 31, 2019.***

**Rabies inoculation must cover at least through October 31<sup>st</sup> of the license year of 2019.**

Please contact the Clerk's Office at 908-234-2250 x116 if you have moved or if the dog is deceased to have your name removed from the unlicensed dog list.

When licensing, by mail or in person, please provide a copy of the rabies certificate and the correct payment and make checks payable to "Borough of Peapack and Gladstone."
