WHEREAS, the Mayor and Council of the Borough of Peapack & Gladstone recognize that all members of the Borough of Peapack & Gladstone Police Department, Fire Department, Rescue Squad and First Responders throughout New Jersey and the United States place themselves in harm's way in order to protect the public and ensure a safe community.
