## TITLED: AUTHORIZING EXECUTION OF A MEMORANDUM OF UNDERSTANDING BETWEEN THE BOROUGH OF PEAPACK AND GLADSTONE AND AFFORDABLE HOUSING DEVELOPER, THE ALPERT GROUP

WHEREAS, the Borough of Peapack and Gladstone has certain legal responsibilities with respect to affordable housing within the Borough, which responsibilities arise by virtue of various New Jersey Supreme Court decisions on the subject; and

WHEREAS, in an effort to fulfill those obligations, the Borough previously acquired a tract of land within the Borough known as the Smith property, with at least one of its predominant purposes to assist the Borough in fulfilling its affordable housing obligations; and

WHEREAS, the Borough has undertaken efforts to contract with a developer for the construction of twenty (20) affordable housing units on the Smith property, and more specifically has commenced negotiations with developer, The Alpert Group, for the aforesaid purposes; and

WHEREAS, the Borough Council of the Borough of Peapack and Gladstone believes it to be in the best interests of the Borough and its residents to memorialize certain terms of understanding in a written memorandum (hereinafter "Memorandum of Understanding" or "MOU") as between the Borough and The Alpert Group in order to explore the potential retention of The Alpert Group for the development of the referenced affordable housing units; and

WHEREAS, Municipal Counsel to the Borough has reviewed said Memorandum of Understanding and has recommended the MOU to the Borough Council for its review and consideration, and the Borough Council having considered same;
