WHEREAS, the Borough of Peapack & Gladstone has a project entitled "Highland Avenue Paving Project"; and

WHEREAS, pursuant to Resolution 160-19 passed on September 24, 2019, the Borough of Peapack & Gladstone awarded and executed a contract with Fischer Contracting, Inc. for the Project in the total amount of \$199,782.05 for the base bid; and

WHEREAS it is the recommendation of the Borough Engineer that Alternate Bid No. 1 also be awarded to Fischer Contracting Inc.; and

WHEREAS, the cost of the change order, dated February 5, 2020, is a \$10,429.43 increase from the original contract price; and

WHEREAS, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the originally awarded contract price to be exceeded by more than twenty percent (20%) and;

WHEREAS, the Chief Financial Officer of the Borough has certified that sufficient funds are available.

NOW, THEREFORE BE IT RESOLVED that the Mayor and Borough Council of the Borough of Peapack & Gladstone, County of Somerset, State of New Jersey, that it hereby authorizes Change Order No. 1 for an increase of \$10,429.43 from the original contract price for the Highland Avenue Paving Project, resulting in a total contract price of \$210,211.48 with Fischer Contracting Inc.
