



The regular meeting of the Mayor and Council of the Borough of Peapack & Gladstone was held on Tuesday, November 24, 2020 electronically via the GOTO Meeting Conferencing Service and began at 6:02p.m.

Mayor Skinner called the meeting to order. Borough Clerk Nancy A. Bretzger read the Sunshine Notice "Pursuant to the Open Public Meetings Act, Adequate notice of 2020 Meeting Dates was published in the Courier News and Bernardsville News on December 5, 2019, and posted at the Municipal Complex and the Borough Library. Action may be taken."

Mayor Skinner led the Pledge of Allegiance.

EXECUTIVE SESSION

RESOLUTION NO. 195-20 — Authorization for Executive Session for Certain Specified Purposes — (1) Contract Negotiation — Affordable Housing was read. Motion was made by Councilman Caminiti, seconded by Councilwoman Dietrich. Said motion was carried unanimously.

Public Meeting reconvened at 7:01 p.m.

MAYOR'S UPDATE ON COVID-19

Mayor Skinner said that there are 3-6 active cases currently in the Borough, all with mild symptoms. One (1) Borough employee had tested positive, but is now back to work. Somerset County has had 8,900 cases and 533 deaths to date. Randy spoke about the in-town drive through testing which should start around December 10.

Mayor Skinner asked if any member of the Public wishes to speak about non-agenda items.

No one came forward.

OLD BUSINESS

Liberty Park —Councilman Smith explained the status of two permits with the NJDEP. We have received a fairly detailed letter from The Threatened and Endangered Species Group explaining that we need to make some changes to the plans for the park. These changes are being challenged by the Architect and Committee. We are on track to receive the permit on or around January 31 of next year. The second





permit is for the spillway at the southern end of the pond, and it is likely that we will receive it early next year. Councilman Sweeney asked if they identified endangered plants. Councilman Smith responded that the letter we received was very detailed and did identify such plants.

Councilman Caminiti spoke about the energy aggregation program. We have negotiated a lower price for electricity generating costs. Councilman Sweeney asked how long we will be locked in with those rates. Councilman Caminiti responded that it is a yearly contract which will lock in the rates and the residents will be able to opt out at any time they may choose. Councilwoman Dietrich gave an update on the lime kiln. She thanked Randy for working with the Historic Preservation Commission and the Environmental Commission for sharing their grant to help with the landscaping costs. She also thanked the DPW for their help. Benches and a sign will be coming soon and she is happy to see it all coming together. Councilwoman Murphy mentioned that she had been in touch with the DPW about getting electricity to the lime kiln. They are working on getting an estimate for the cost, and she will let Council know when she receives that information.

Administrator Bahr asked Attorney Bruder about the previous Ordinance for the same item, which was worded slightly different. Attorney Bruder indicated that that prior Ordinance would lapse.

Roads & Transportation - Councilwoman Dietrich stated that she had nothing to report at this time.
