



The regular meeting of the Mayor and Council of the Borough of Peapack & Gladstone was held on Tuesday, November 23, 2021 at the Municipal Complex, 1 School Street, Peapack, New Jersey and began at 7:02pm.

Mayor Skinner called the meeting to order. Borough Clerk Nancy A. Bretzger read the Sunshine Notice "Pursuant to the Open Public Meetings Act, Adequate notice of 2021 Meeting Dates was published in the Courier News and Bernardsville News on December 3, 2020 and posted at the Municipal Complex and the Borough Library. Action may be taken."

Mayor Skinner led the Pledge of Allegiance

PUBLIC COMMENTS - 5 MINUTES PER PERSON - NON-AGENDA ITEMS

Mayor Skinner asked if any member of the public wishes to speak about non-agenda items. No one came forward.

OLD BUSINESS

Councilman Lemma asked if there was an update on the Fire Department having access to the finance system. Nancy Bretzger, Administrator, responded by saying that she is working on resolving some issues with that.

Councilman Lemma asked who we can notify about the Park Ave. closure as this is no longer a road.

Mayor Skinner mentioned that residents have been inquiring about the quite zone regarding the train whistles. He would like to put together a public information center so people can get involved in discussing this process.

Councilwoman Murphy mentioned that a few months ago we ok'd monies for the Smith property. Mr. Smith has sent in his half, and the appraisals are moving forward.

NEW BUSINESS

Councilman Sweeney spoke about reopening open gym and suggested having residents fill out a Facilities Usage Application to request time to use the gym. Discussion ensued and it was decided that there would need to be a defined time for gym use as well as guidelines in place.





MISCELLANEOUS DISSSION/APPROVALS

Council discussed the mandate for wearing masks in the Municipal Building. Discussion ensued and it was decided that masks should no longer be required, but suggested. New signs will be ordered and hung in the Municipal Building.

MINUTES

Motion made by Councilman Caminiti, seconded by Councilman Sweeney. Council President Corigliano asked that a change gets made to this resolution, thanking Sergeant Scanlon for his guidance over the past few months. Motion for amendment made by Council President Corigliano, seconded by Councilman Caminiti. Said motion passed unanimously.

BILLS LIST

RESOLUTION NO. 206-21 – Approval of Bills as Signed and Listed on the Bill Payment List **Total Amount:** *\$822,704.48* was read. Motion to approve payment was made by Councilwoman Murphy, seconded by Council President Corigliano. Said motion passed unanimously.

COUNCIL REPORTS

Finance – Council President Corigliano stated he had no report.

Sanitation & Sewer - Councilman Lemma stated he had no report

<u>Borough Property</u> – Councilman Caminiti gave an update on Liberty Park. V&K Construction has planted some trees which Carter Van Dyke was not aware of. They will need to be replanted in the spring at V&K Construction's cost. Nancy Bretzger, Administrator, informed Council that these are the trees that were originally chosen, but due to the oak tree needing to come down, there is no longer enough shade for this type of tree in this area. There is also another oak tree that needs to be removed which will cause a change work order. He will have the final numbers for this cost soon.

Councilman Caminiti stated that Dan Megill, DPW, is still working on a list of needed repairs at the Park House, since there was damage done by the dentist who was renting it from the Borough. Although the dentist requested to be able to make said repairs himself, Council agreed that the Borough should make the repairs and then refund any money left to the tenant.

Council President asked to be excused from the remainder of the meeting. Mayor Skinner said yes.





Councilwoman Murphy mentioned that there have been some complaints about the nature of the Santa and snowman cut outs that get displayed. She suggested that they get repainted, possibly by a local artist, so they are not so scary.

<u>Fire and First Aid</u>—Councilwoman Murphy stated that she is still waiting for updated pricing for the Rescue Fire truck.

Roads & Transportation - Councilman Caminiti stated he had no report.

Zoning & Construction - Mayor Skinner stated he had no report.

Borough Attorney's Report- John Bruder stated he had no report.

<u>Police</u>—Councilman Sweeney mentioned that our Police Department had received a harassment terroristic threat complaint against juveniles, which resulted in a temporary Extreme Risk Protective Order and 31 fire arms being seized from a Bernardsville resident.

Administrator's Report - Nancy Bretzger stated that she had no report.

Mayor's Report - Mayor Skinner stated that he had no report.
