

## MAYOR & COUNCIL THE BOROUGH OF PEAPACK & GLADSTONE, BOROUGH COUNCIL MEETING MINUTES OCTOBER 11, 2022



The regular meeting of the Mayor and Council of the Borough of Peapack & Gladstone was held on Tuesday, September 13, 2022 at the Municipal Complex, 1 School Street, Peapack, New Jersey and began at 7:01p.m.

Mayor Skinner called the meeting to order. Borough Clerk Nancy A. Bretzger read the Sunshine Notice "Pursuant to the Open Public Meetings Act, Adequate notice of 2022 Meeting Dates was published in the Courier News and Bernardsville News on December 9, 2021 and posted at the Municipal Complex and the Borough Library. Action may be taken."

Mayor Skinner led the Pledge of Allegiance.

Roll Call indicated the following present: Mayor Skinner, Councilman Caminiti, Council President Corigliano, Councilwoman Dietrich, Councilman Lemma, and Councilwoman Murphy

Absent: Councilman Sweeney

Also present were: Mr. Frederick Rubenstein sitting in via GoTo Meeting for Mr. John Bruder, Esq., Borough Attorney, and Nancy A. Bretzger, Borough Clerk/Administrator

#### **PROCLAMATIONS**

Mayor Skinner read a proclamation commending Matheny Medical and Educational Center for their 75<sup>th</sup> anniversary.

#### PUBLIC COMMENTS - 5 MINUTES PER PERSON - NON-AGENDA ITEMS

Chris Downing - Mr. Downing stated that he feels Main St. is unsafe due to the lack of a bike lane, the 1" drop from the recent resurfacing, and the crosswalks not being repainted. Mr. Downing also stated his concerns with the Red Horse Motoring Club who held an event where alcohol was served not in accordance with LUB conditions.

### **OLD BUSINESS**

Councilman Lemma gave an update on the Liberty Park Improvement Project. He stated that the project is essentially finished, and there will be a meeting with the landscape architect, Carter Van Dyke, for a substantial completion inspection, and to look at the options for maintenance.

#### **NEW BUSINESS**

Council President Corigliano stated that there was an email from the New Jersey Council of Mayors regarding the increase in state healthcare costs for municipal employees. Concurrence was given by Council to send a letter to Governor Murphy asking for reconsideration.

Councilwoman Dietrich spoke about signage at Liberty Park on the History of the park. It was discussed that the kiosks should be utilized so the signs would be protected. Council concurred.

#### MISCELLANEOUS DISCUSSION/APPROVALS

Mayor Skinner mentioned that the Fire Department Open House was a success with a great turn out. He also mentioned that there were some recent car break ins in Peapack & Gladstone and surrounding towns in which the Peapack & Gladstone Police Department assisted in arrests. Mayor Skinner then spoke about doing a bleeding control class for Borough employees and Council members.
